DLG Utilizes Witnesses to Settle Cases



Jim got into his vehicle on a Monday evening as he planned to head to the suburbs to visit his grandmother. He got onto Lake Shore Drive, where a light mist covered the roadway from a heavy rain that had occurred earlier in the day.

As he came to a complete stop at a red light on Lake Shore Drive, he admired the beautiful view of Lake Michigan. In that moment, he felt calm, peaceful and happy that he was about to visit his grandmother, whom he hadn't seen in awhile. But a taxi driver by the name of Louis was about to change everything.

Louis, eager to get home after ending his long shift, quickly weaved in and out of the lanes on Lake Shore Drive. Speeding on the slippery roads, he suddenly discovered there was a red light in front of him and halted on his breaks to stop. Unfortunately he couldn't. It was too late.

Louis rammed into the back of Jim's vehicle with his vehicle, causing Jim to be violently thrown around the interior of his car. **Jim ended up suffering severe injuries, including cervical and lumbar spine sprains, as well as a left shoulder rotator cuff tear that required surgery.**

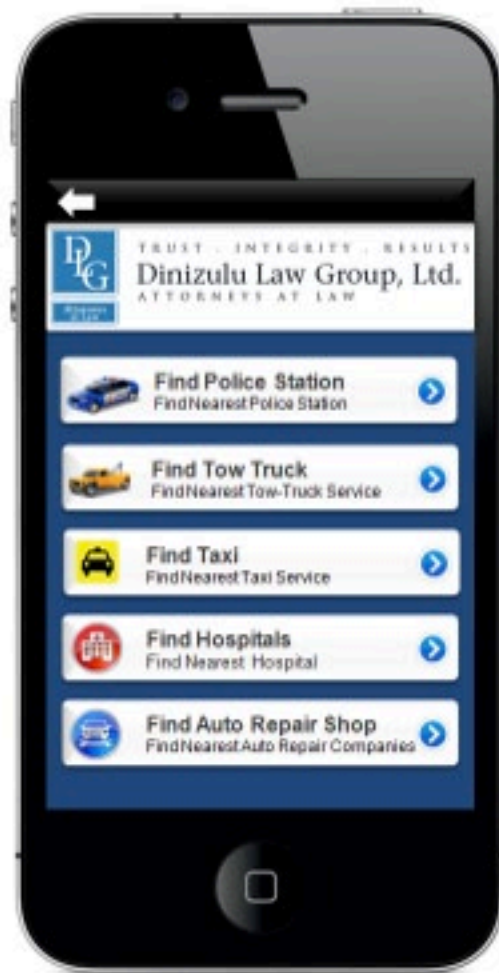
